ORGANIZERS: The Cupping Competition will be organized by the HCA and will be run by Professional Cuppers – Wholesale Coffee Roasters & Brokers from the mainland USA

ENTRIES: The Cupping Competition will be open to all coffees grown 100% in the Hawaiian Islands and Certified by origin by the Hawaii State Dept. of Agriculture

SUMMARY: The Cupping Competition will give growers and consumers a better understanding of the cupping process and how to rate different coffees on various cup qualities. It will also allow exposure to local and mainland markets as to the quality and diversity of Hawaiian grown coffees.

HOW TO GET COFFEE CERTIFIED FOR THE HAWAII COFFEE ASSOCIATION'S HAWAII STATE CUPPING COMPETITION

Coffee entrants for the Hawaii Coffee Association's statewide Coffee Cupping Competition need to submit 2 pounds of state certified, green coffee for entry in the Hawaii State Cupping Competition. All samples need to be certified by the Hawaii Department Agriculture.

If your coffee has **already been certified**, simply submit the corresponding copy of the HDOA certificate (form C-2) with your 2 lb. entry. Please see contest entry instructions at page bottom.

If your coffee **needs certification**, take a 10 lb. sample lot to the HCA designated site in your region by **APRIL 30, 2010**. **HCA has designated sites to help the HDOA. West Hawaii – Greenwell Farms. East Hawaii – Ka'u Farm & Ranch. Maui –Maui Oma Coffee Roasting**

Your sample lot should be sealed and have an index card sized tag attached when submitted. The tag should have the farm name and address, net weight and the contact information for the owner. Aside from the information about the farm and owner, leave a 2" x 2" blank space for the HDOA to put the Certification stamp.

HDOA inspectors will pull official samples and test to see if they meet minimum standards of Prime Grade or Better and moisture parameters of 9.0% to 12.2% to pass certification for area of origin. After sampling the remainder of the lot will be returned to the applicant.

An HDOA Certificate of Origin Application (form C-4) also needs to accompany a green sample lot for certification. A blank C-4 PDF form can be downloaded at www.hawaii.gov/hdoa/qad/comm/qad-c-4.pdf To find your tax map key number for your coffee growing location see:
